# MINUTES TOWN OF EAST FISHKILL TOWN BOARD MEETING MAY 23, 2019 7:00 p.m.

#### REGULAR BOARD MEETING

The Town of East Fishkill's Town Board Meeting on May 24, 2019 was called to order at 7:00 p.m. by Supervisor D'Alessandro with the Pledge of Allegiance to the Flag, led by Girl Scout Troop 10354. Supervisor D'Alessandro presented Victoria Lorenzo with the Presidential Volunteer Service Award and a proclamation from the Town.

#### Supervisor's Announcements

Supervisor D'Alessandro stated he held a town-hall style meeting at the Community Center with County Executive Marcus Molinaro. It was about County Finances, recreation, and development.

May 4<sup>th</sup> was the K104 Cupcake Festival at the Stormville Airport. It was very successful.

May 5<sup>th</sup> was the annual Fire District Inspection of the equipment. He thanked all the volunteers for all their efforts and the Commissioners for their work.

May 6 there was a meeting with New York State Department of Transportation regarding replacing the Route 82 bridge by Williams Lumber in 2020-2021.

They are discussing a few different options at this point.

Supervisor D'Alessandro has met with the Business Economic and Development Committee. There will be a business forum at Town Hall on June 4 at 6 PM. All local businesses will be invited.

On Tuesday, May 7 he met with the Dutchess County Mayors and Supervisor's for their monthly meeting. Dutchess County Department of Health was the main discussion point.

Supervisor D'Alessandro has been meeting with East Fishkill's IT consultants and the Town Comptroller as they are planning a large IT project. It will include new wiring and new equipment. Bids will be sent out soon.

There have been many calls with the EPA regarding the Hopewell North Water District. There was a meeting on May 14th at the community center that was well attended.

Last week he had a meeting with the East Fishkill Historical Society. They will be having their Annual Strawberry Festival on June 2 from 1 to 4 PM. It is a wonderful event.

The Supervisor and Town Attorney had a conference call with a senior District Attorney regarding an issue of missing funds that has been under investigation. It is now being referred to the District Attorney's office. Once the Town knows more, they will share it.

Last Thursday was a celebratory ceremony with the Dutchess County Sheriffs for their members who gave their life in the line of duty. It was a wonderful ceremony. Supervisor D'Alessandro met with some residents and the Tax Assessor regarding some assessments.

There was a meeting yesterday with Central Hudson regarding the 1968 electric transmission lines from Joe's Dairy Bar to Montfort Road.

There was a Memorial Day ceremony at John Jay High School yesterday and it was very nice.

This Monday is the annual Memorial Day parade and celebration. It will start at 10:45 from the Community Center to the War Memorial.

#### Public Hearing:

### 1. Public Hearing for Modifying Zoning Procedures with Respect to Architectural Review Board

Motion to open the Public Hearing: Board Member Beephan. Seconded: Board Member Franco. All voted in favor. Motion carried.

Supervisor D'Alessandro stated this public hearing is being open so that it can be adjourned until June 27 as it needs to be referred to Dutchess County Planning and the East Fishkill Architectural Review Board and Planning Board. The Town Board does have a copy of the zoning to be reviewed.

a. Adjourn Public Hearing to June 27, 2019

Motion to adjourn the Public Hearing to June 27, 2019 to refer to Planning Board, Dutchess County Planning and Architectural Review Board: Board Member Beephan. Seconded: Board Member Marinaro. All voted in favor. Motion carried.

#### 2. Public Hearing for the Shed and Fence Amnesty Law

Motion to open the Public Hearing: Board Member Franco. Seconded: Board Member Beephan. All voted in favor. Motion carried.

Supervisor D'Alessandro stated they have been discussing this for a while. It is an item that comes up a lot in the Zoning Board meetings and they are looking to try to give amnesty to people who have fences and/or sheds that never had permits. The overview is that for residents who have erected fences and sheds that don't comply with Town Code this will allow, with certain circumstances, to legalize those fences and sheds. They are looking at December 31, 2013 and back as the time frame that would be covered. Anything from 2014 forward would require residents to come in to get permits.

Attorney Wood stated this would grant amnesty for anyone who could come in and prove that their shed or fence was on their property prior to December 31, 2013. The reason is that many times people purchase homes and then realized that the shed is not in compliance with the side yard setbacks, etc. so this would allow forgiveness under those circumstances. Many times there are fences that were installed prior to the changing of the laws over the years. This will allow owners to get a certificate. If it needs to be replaced at some point then it must comply with the current existing law. There are two types of requirements; one is for sheds under 120 square feet that do not require the state building permit, so as long as it does not have electrical service, not in the front yard, and not within an easement area or a wetland area, and proof of existence prior to 2014 it would be granted amnesty. There are also some requirements for larger sheds. The fences need to be in good repair. They cannot exceed 6 feet in height. Many years ago they were put right on the property line and current zoning requires them to be 2 feet from the property line. The Town is looking to allow those fences to remain as long as they have been there for that period of time. It then goes into requirements for how you file with the Building Department, etc.

Supervisor D'Alessandro stated they would allow people to come in from June 2019 to June 1, 2020 to prove that the shed or fence has been there prior to December 31, 2013. If it meets all of these certifications they would be allowed to have the amnesty and get the Certificate of Occupancy. After that year is up, you would have to come in and get the permit like you have to do now.

Supervisor D'Alessandro asked if there were any questions or comments from the Town Board. Board Member Cassidy asked if this was for residential properties only and Attorney Wood said yes. Board Member Cassidy asked what if it was commercial property and Attorney Wood stated commercial property would have to go through a regular process of showing that it complies with codes.

Board Member Marinaro believes this is something that needs to be done.

He asked if there were any questions or comments from the public.

Anthony DeCostanzo thanked the board for the opportunity to resolve prior existing issues. He also thanked the Town Board for use of the Joe DiMaggio field

for the Sons of Italy Festival this weekend.

#### a. Close Public Hearing

Motion to close the Public Hearing: Board Member Franco. Seconded: Board Member Beephan. All voted in favor. Motion carried.

#### b. Adopt Negative Declaration and Laws

#### LOCAL LAW NO. 6 OF 2019

#### "Shed and Fence Amnesty in the Town of East Fishkill"

#### 1. Legislative Intent

The Town Board of the Town of East Fishkill understands that despite acting in good faith, residents have erected sheds and fences in ways that do not comply with the Code of the Town of East Fishkill. This local law shall allow residents, under the circumstances set forth herein, to legalize existing sheds and fences.

#### 2. Applicability

This section shall apply only to the following types of sheds and fences constructed or erected on or prior to December 31, 2013, without benefit of a building permit that meet the following criteria:

- A. Sheds having a size of 120 square feet or less and that are:
- i. Without electrical service;
- ii. Not located in a front yard;
- iii. Not located in a water, sewer, storm sewer or other utility easement; and
- iv. Not located in a wetland or wetland buffer area; or
- B. Sheds having a size from 144 square feet to 350 square feet or sheds of any size with electric service and that are:
- i. Not located in a front yard;
- ii. Not located in a water, sewer, storm sewer or other utility easement;
- iii. Not located in a wetland or wetland buffer area; and

- iv. Located at least six feet from the rear or side property line; or
- C. Fences that are:
- i. In good repair, which excludes fences with peeling or chipping paint or fences that are missing pieces;
- ii. Level with grade and without any slanting;
- iii. Contain fence panels that are securely fastened to fence posts;
- iv. No larger than six (6) feet in height;
- v. Not located in a front yard; and
- vi. Not located in a wetland or wetland buffer area.

#### 3. Amnesty

Such sheds and fences and described in the "Applicability" section of this local law shall be eligible for a certificate of legal nonconformity issued by the Building Department upon registration of the shed or fence with the Building Department and upon submission of the owner's certification as hereinafter provided.

#### 4. Registration

Unless a valid certificate of occupancy exists for a shed or fence, as of the date of this local law, all property owners must register the shed or fence with the Building Department, on or before, June 1, 2020, and apply for a certificate of legal nonconformity upon forms to be supplied by the Building Department. Each property owner may only register one shed per lot.

#### 5. Owner's Certification

Any owner who registers a shed or fence erected on or prior to December 31, 2013, may obtain a certificate of legal nonconformity for said shed or fence upon submission of an Owner's Certification containing the following information:

- A. A photograph of the shed or fence;
- B. Proof that the shed or fence was erected on or prior to December 31, 2013. Acceptable proof includes, but is not limited to, invoices or affidavits;
- C. For all sheds with electrical service, a certificate of compliance or equivalent from a third-party electrical inspector approved by the Building Department; and

D. A survey completed by a licensed land surveyor providing that the shed or fence complies with all requirements of this local law.

#### 6. Certificate of Legal Nonconformity

Upon registration of the shed or fence and submission of the Owner's Certification, the property owner shall be entitled to a Certificate of Legal Nonconformity issued by the Building Department indicating that the shed or fence is not in violation of the Zoning Ordinance.

#### 7. Requirements for Sheds and Fences Not Registered

Effective with the adoption of this local law, all requirements in the Zoning Ordinance shall apply to sheds and fences constructed on or prior to December 31, 2013 that were not registered with the Building Department on or before June 1, 2020 pursuant to the requirements of this local law.

#### 8. Enforcement; Penalties

Any violation of this local law shall be subject to the same enforcement requirements, including the civil and criminal penalties, provided for in Chapters 80 and 194 of the Town Code.

#### 9. Severability

The invalidity or unenforceability of any section, subsection, paragraph, sentence, clause, provision, or phrase of the aforementioned sections, as declared by the valid judgment of any court of competent jurisdiction to be unconstitutional, shall not affect the validity or enforceability of any other section, subsection, paragraph, sentence, clause, provision, or phrase, which shall remain in full force and effect.

#### REASONS SUPPORTING THIS DETERMINATION:

(See 617.7(c) for requirements of this determination; see 617.7(d) for conditioned Negative Declaration)

The proposed action would result in the adoption of a local law that would allow residents that have acted in good faith and erected sheds and fences in ways that do not comply with the Code of the Town of East Fishkill to legalize their existing sheds and fences provided they meet the conditions of the local law. Since the sheds and fences subject to this law are existing the proposed law would not be expected to result in any significant adverse impacts for the following reasons:

- 1. It will not generate a significant amount of additional vehicles, noise or emission levels.
- 2. It will not affect rare or endangered species of animal or plant, or habitat of such species.
- 3. It will not result in any impacts to historic or archeological resources.
- 4. It will not result in any impacts related to hazardous materials.
- 5. It will not result in a significant effect on air, water quality or ambient noise levels for adjoining areas.
- 6. It will not be subjected to unacceptable risk of flooding or major geological hazards.
- 7. It will not have a substantial aesthetic affect.
- 8. It will not involve adversely affect any surface water or groundwater.
- 9. It will not allow for improper uses within specified zoning districts.
- 10. It will not result in adverse cumulative impacts.
- 11. It will not result in adverse growth-inducing impacts.
- 12. It will not conflict with the Town's Comprehensive Plan.

In conclusion, no significant potential impacts were identified as a result of the Proposed Action. Therefore, based on a review of 6NYCRR 617.7, there appear to be no significant adverse environmental impacts.

**WHEREAS**, the Interim Part-time Economic Director will receive an annual stipend of \$3,500; and

WHEREAS, the position will work with the Town Supervisor and the Economic and Business Revitalization Committee in regards to future economic developments in the Town. Working with outside agencies, the public and local businesses will be functions of the position.

**NOW, THEREFORE, BE IT RESOLVED,** that the Town Board appoints Michael O'Brien as the Interim Part-time Economic Director receiving an annual stipend of \$3,500.

**NOW, THEREFORE, BE IT RESOLVED,** that the Town Board has reviewed the attached rules and regulations and authorizes the adoption thereof.

#### **Budget transfers:**

Supervisor D'Alessandro stated there are no budget transfers at this time.

#### **Comments from Town Board Members:**

Board Member Beephan thanked the police officers, firefighters, and EMS for all the work they do for the Town. Fire and EMS are always looking for new volunteers. The new police K-9 has been received and is currently in training. He thanked everyone who donated to the team East Fishkill Leap for Autism. Greystone Programs is located in I-Park and they are a nonprofit organization that focuses on helping individuals impacted with autism and other developmental disabilities. He continues to do his Hometown Hotspot Tours and he welcomed Kate Rose Bakery as new business in town.

Board Member Franco stated Red Wing opens this Saturday at 11 AM. It will be open every weekend until June 14 when it will open daily. He thanked Highway Superintendent Williams and his crew as the place looks fantastic. The lake looks

wonderful, especially with the new equipment for children of different abilities. Summer Camp registration is still going on and can be done at the Lime Kiln facility. There are still openings for several of the specialty camps as well. The Italian festival is at recreation park this weekend. The Stormville Flea market is open this weekend. There is a Memorial Day Soccer Tournament at the sports complex on Route 52. It will be very heavily trafficked there this weekend. Board Member Marinaro gave the monthly report from the Police Department. He thanked Sgt. Cuccia for all of his hard work in helping maintain the state accreditation that the Police Department has. He thanked everyone in the department for doing a phenomenal job. He stated that he joined the Hillside Lake Fire Department as a volunteer. It's extraordinary work that they do. If anyone has free time this is a wonderful thing to do. He stated the Memorial Day parade is a great time to commemorate all of those who sacrificed to give us all of our freedoms.

Board Member Cassidy thanked the fire and EMS. He stated highway is doing a great job and getting potholes patched up. He wished everyone a happy Memorial Day. He asked everyone to please attend the Memorial Day service on Monday.

Highway Superintendent Williams stated they have been very busy. They've been changing rotten pipes on Stormville Mountain Road, Mountaintop Road, Carol Drive, Martin Road, as well as extensive drainage work on Orbit and Long Hill. They have been doing catch basin repair by Warren Farms Road, Sunshine Lane, Quints Lane, Willow Lane, Cross Road, Sebastian court and Queen Anne. They've been patching roads every day it hasn't been raining as well as doing quite a bit of work in the parks and getting all the banners up. He thanked his crew and the recreation group because they've all been very busy.

Police Chief Orsino thanked the Town for recognizing police and EMS and all that they do. He stated this is the busiest weekend of the year for the Police Department. He asked everyone to be responsible as resources are spread thin. Please don't drink and drive.

Supervisor D'Alessandro reminded everyone of the June 2 Strawberry Festival and this Monday is the Memorial Day parade at 10:45 AM from the Community Center. He congratulated Board Member Marinaro for joining the volunteer fire department. He thanked Clare Moran for her volunteering. He reiterated to the public to please call the town offices with any questions. Do not rely on Facebook for accurate information. He wished everyone a nice Memorial weekend.
